For a finder's fee of \$35.00 **A-24 Hour Notary and Ink Fingerprinting Service** will provide leads to you for the purpose of acting as a Notary Public and providing such service. Our mobile fee is \$60.00 and \$10.00 for each page notarized between the hours of 8:30am – 8:30pm. Our mobile fee for **jails and airports** is \$100.00, and \$10.00 for each notary stamp. A surcharge of \$5.00 for every half-hour before 8:30 am or after 8:30pm will be added to the mobile fee for all early and late appointments. **Do not** charge a customer *extra fees* other than what we have quoted to them. You keep all fees, except the finder's fee of \$35.00 for 1-9 signatures
 10-24 signatures is 20% of the total
 25 and up is 30% of the total.

If you do not notarize a signature, please collect the mobile fee (\$50.00) and remit \$25.00 to us.

A-24 Hour Notary and Ink Fingerprinting also offers loan document signing services. If you participate as a notary public by providing such loan document signing service, the fee is generally 75% to you and 25% to A-24 Hour Notary and Ink Fingerprinting Service. Note: Loan Signings are normally billed at the rate of \$100 - \$150

We also take appointments from companies that need to be billed or pay with a credit card. As a convenience to those companies and you, we will bill these accounts. Your payment will be forwarded to you within 30 days of A-24 Hour Notary being PAID.

You understand you are an independent contractor, you have contracted with our company merely to be provided with leads as stated above. You also understand that any lead given to you is the property of A-24 Hour Notary and Ink Fingerprinting Service. **You cannot hand out your business card on the appointment unless it is printed with our 800 number and you instruct them to call us. If a customer contacts you directly, you must inform our office immediately.** (Please Initial _____)

You will remit all fees due within 10 days made payable to **A-24 Hour Notary**. We do not provide invoices for you. Failure to remit fees on a weekly basis shall be considered grounds for termination of this agreement and being forwarded to a collection agency. **Overdue fees may be subject to a \$15.00 late fee per lead. Any returned checks will be charged an additional \$35.00 fee.**
